## CORRIGENDUM

The Corporation invited tenders for supply of serviceable old 50kg gunnies to be delivered at various buffer godowns /MLS Points/PPCs of TSCSCL in the Districts of Telangana State through e-procurement platform vide **e-Tender Notice NO.MKTG/M2/OSB/KMS 2021-22, Dtd:10.09.2021.**

As per the tender schedule a pre-bid meeting has been conducted with the intended tenders on 25.09.2021 to ascertain the possibility of getting the required quantities of old serviceable gunnies. After examining the suggestions made by the participants and to get the required quantities of old serviceable gunnies supplied with in the stipulated time, it has been decided to make the following amendments in the tender terms and conditions and agreement.

**FORMAT OF THE UNCONDITIONAL AND IRREVOCABLE BANK**  
**GUARANTEE FOR CONTRACT SECURITY**

Any such demand made on the bank shall be conclusive as regards the amount due and payable by the bank under this guarantee. This BANK GUARANTEE shall not be affected in any manner by reason of merger, amalgamation, restructuring or any other change in the constitution of the Guarantor Bank.

- 4) I/We, \_\_\_\_\_ further agree with the Corporation that the Corporation shall have the fullest liberty without our consent and without affecting in any manner our obligations hereunder to vary any of the terms and conditions of the said agreement with the mutual consent of the parties to that agreement or to extend time of performance by the said supplier from time to time or to postpone for any time or from time to time any of the powers exercisable by the Corporation against the said supplier and to forbear or enforce any of the terms and conditions relating to the said agreement and we shall not be relieved from our liability by reason of any such variation or extension being granted to the said supplier or for any act of forbearance or omission on the part of the Corporation or any indulgence by the Corporation to the said supplier or by any such matter or thing whatsoever which under the law relating to sureties would but for this provision have effect of so relieving us, subject, however, to clause No.6 herein below.
